After you register for a class, be sure to complete the following steps:

Get the material. After you have paid for the class, your study guides will be mailed to you and the exam simulator link and log in information will be emailed to either the participant or the agency owner as instructed. If you do not receive the materials in a timely manner, please contact us.

Review the Material. Study the material intently prior to the class. Our successful student feedback tells us that this is one of the keys to success in passing on the first attempt.

Register for the exam. The exams are administered for the State of Alaska by PearsonVue. We strongly recommend taking the exam within one week of the class if possible. Leave yourself a few days to review the material and take practice exams, but take the exam within 2 weeks of taking the class so the examples given in class have not faded.

PearsonVue: We suggest registering for the exam early to secure the date you want. The phone number for PearsonVue is (800) 274-5993. You may also use their online option https://home.pearsonvue.com. If you register for the two parts (property/casualty or life/health) on the same day, you avoid paying the exam fee twice. If you separate the exams, you will pay **two** exam fees.

NOTE: exams are now available online with a web based proctor as long as your computer is equipped with a webcam.
