### Payment and Cancellation Policy (please read before signing)

- Cash, Credit Cards, Debit Cards, Agency Check, Cashier Check or Personal Check are acceptable forms of payment. Please use the Pay Pal option on our registration page to pay with a credit or debit card.

**After you register for a class, be sure to complete the following steps:**

**Get the material.** After you have paid for the class, your study guides will be mailed to you.

**Review the Material.** At the very least, skim over the material, but if you can, study it intently prior to the class. Our student feedback has told us that this was very useful for them and helped them better understand the material when presented in class.

**Register for the exam.** The exams are administered for the State of Alaska by PearsonVue. We strongly recommend taking the exam within one week of the class if possible. Leave yourself a few days to review the material and take practice exams, but take the exam within 2 weeks of taking the class so the examples given in class have not faded.

**PearsonVue:** We suggest registering for the exam early to secure the date you want. The phone number for PearsonVue is (800) 274-5993. You may also use their online option <https://home.pearsonvue.com>. If you register for the two parts (property/casualty) back to back, you avoid paying the \$89 fee twice. If you separate the exams, you will pay **two** \$89 fees.

**NOTE: exams are now available online with a web based proctor as long as your computer is equipped with a webcam. There is no discount for scheduling back to back exams when you choose the web based option.**
